The General Union has been negotiating with boards of education and dispatch companies for the last 20 years and we have made some important gains especially in forcing dispatch companies to abide by the Labour Standards Law for paid holidays and overtime and getting the employers to enrol teachers on social insurance.

Our main push now is to work with government ministries to get some kind of ALT national standards for both working

conditions and the quality of education. We can only do this by working together - dispatch, direct-hire, JET - to stamp out poor working conditions in the whole ALT industry. Our starting point is to back up our claims with solid data and that means pushing our national survey to all our ALT friends and colleagues.

We Denounce this Miscarriage of Justice!

不当判決糾弾!!

An appeal verdict was heard in the “Osaka #1 Incident” case, in which the Osaka District Court in December of 2017 made an unfair ruling to smash a strike that was carried out by Zennikken Solidarity Union, Kansai Ready-Mix Concrete Branch (Kansai Nama-Kon, or Kan’Nama).

Kan’Nama Branch members and their supporters held a sit-in rally in front of the courthouse starting at 9:30 that morning. With all believing as one that the District Court ruling be overturned on appeal. However, the ruling handed down by the court was “appeal rejected” another unfair verdict. Imprisonment or suspended sentences for defendants were not revisited.

5月23日、大阪高裁で2017年12月に全日建連帯労組関生支部が取り組んだストライキへの不当弾圧裁判である「大阪第1次事件」裁判の控訴審判決がおこなわれた。この日、関生支部と支援は9時30分から裁判所前の公園で座りこみ集会を開催し、1審地裁判決は覆されて当然という意味一致の下、無罪判決を待ち構えていた。しかし、11時に開廷された判決公判で言い渡された判決は「本件各控訴をいずれも棄却する」という不当なもの。各被告人への懲役および執行猶予も全く見直されず。
