GU members file lawsuit against Osaka University demanding unlimited employment

組合員、無期雇用契約を求めて大阪大学を提訴

Two General Union members who have been working at Osaka University (Handai) continuously for fifteen years filed a

lawsuit against the university on 31 August. The basic demand in the suit is that the university accept their application for unlimited term contracts (UTC) that they filed during the 2021 academic year.

NEW DEAL for ALTs

ALTを使い捨てにする教育を変えよう!

The General Union has been negotiating with boards of education and dispatch companies for the last 20 years and we have made some important gains especially in forcing dispatch companies to abide by the Labour Standards Law for paid holidays and overtime and getting the employers to enrol teachers on social insurance.

外国語指導助手（Assistant Language Teachers = ALT）は、1970年代から日本に存在しています。政府の交換留学制度による一握りの参加者から始まりましたが、現在では幼稚園から高校まで、2万人近い教師が働いています。ALTはまともな仕事をする資格があります。そして、日本の先生も学生・生徒も質の高い教育を提供するまともなALTを必要としているのです。「まともなALTの仕事」とは、労働法が遵守され、安定していて、成長の機会が与えられ、明確な目標と期待があり、他の教師たちと同様の処遇を受けるものです。

We can only do this by working together - dispatch, direct-hire, JET - to stamp out poor working conditions in the whole ALT industry. Our starting point is to back up our claims with solid data and that means pushing our national survey to all our ALT friends and colleagues.
